## Ninth copper-gold concentrate shipment to depart port today

**Perth, Australia:** Alara Resources Limited (ASX: AUQ – **Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce that the ninth shipment of copper-gold concentrate from its recently completed Wash-hi Majaza mine and processing plant is scheduled to leave Sohar Port for China.

### Ninth Copper-Gold concentrate shipment due to leave port today

The Al Wash-hi Majaza copper-concentrator plant has achieved production of 1210.8 WMT of copper-gold concentrate with approximately 211 MT of contained copper and 6.6 Kg of contained gold. This comprises the ninth parcel of copper-gold concentrate due to be shipped from Sohar Port, on 16 December due to a shipping delay.

The table below compares the latest to the two previous shipments and demonstrates continuing improvement in the grade of concentrate.
