**RESULTS OF ENTITLEMENT OFFER AND PRIORITY OPTION OFFER**

**Argent Minerals Limited (ASX: ARD) (Argent or the Company)** that the pro-rata non-renounceable Entitlement Offer (“**Entitlement Offer**”) and Priority Option Offer (“**Priority Option Offer**”) (together, the “**Offers**”) as announced to ASX on 21 November 2024 and detailed in the Prospectus lodged on 21 November 2024 (“**Prospectus**”), closed on Tuesday, 10 December 2024.

The Company sought to raise \$144,564 with the Entitlement Offer comprising one (1) option exercisable at \$0.042 and expiring on 10 December 2027 (**New Option**) for every ten (10) fully paid ordinary shares (Shares) in the Company at an issue price of \$0.001 per New Option.

In addition to the Entitlement Offer, the Prospectus contained a non-renounceable entitlement issue of one (1) New Option for every one (1) listed ARDO option (ARDO Option) at an issue price of \$0.001 per New Option to raise a further \$143,500.

The Company is pleased to announce that it has accepted applications for new entitlements and options from eligible shareholders who applied for 38,669,712 New Options under the Entitlement Offer, and additional 85,974,300 New Options under the Priority Option Offer, raising \$124,644.01 (before costs).
