### 5GN Takeover Bid

AUCyber Limited (ASX: **CYB** or the “**Company**”) has today received an unsolicited and unconditional on-market takeover bid from 5GN Networks Limited (**5GN**) for 100% of the ordinary shares in the Company at \$0.11 cash per CYB share (**Offer**).

As announced to ASX on 20 December 2024, 5G Networks Limited (ASX:5GN) has recently acquired a stake of 10.74% in the Company.

### SHAREHOLDERS TAKE NO ACTION

The Board is in the early stages of evaluating the Offer and advises shareholders to **TAKE NO ACTION**.

The Offer represents a modest 0.9% premium to the 5-day VWAP to 19 December 2024.

### Non-Executive Director Shareholders

Related entities of the Non-Executive Directors of the Company have a relevant interest in approximately 40.6% of the ordinary shares of the Company, broken down as follows:

- Craig Scroggie<sup>1</sup> – 31.96%
- Cathie Reid – 7.59%
- Ross Walker – 1.09%

At this time the Non-Executive Directors and their related entities intend to **TAKE NO ACTION** in relation to the Offer.

### Next Steps

The Board intends to shortly engage legal and financial advisers in relation to the Offer and other potential alternative options to maximise shareholder value.

The Board will continue to evaluate the Offer and will respond to shareholders through a formal Target Statement in the coming weeks.

The Offer closes on 6 February 2025, unless otherwise extended.
