REQUEST FOR EXTENSION TO VOLUNTARY SUSPENSION

In accordance with Listing Rule 17.2 St George Mining Limited (“St George” or “Company”) requests that the Australian Securities Exchange (“ASX”) grant an extension to the voluntary suspension on the Company’s securities with immediate effect.
