## NEW CONTRACT WINS

EVZ Limited (ASX: EVZ), a leading provider of innovative engineering solutions, is pleased to announce that it has been awarded two contracts in the Energy & Resources sector through its wholly owned subsidiary Brockman. The total value of these contracts is circa \$28.5M.

The new contract awards include:

### Hastings Fuel Terminal Expansion, VIC

Brockman has been awarded the contract for the engineering and construction of the next stage of the Hastings Terminal Expansion for United Terminals. The project works include the addition of two new bulk fuel storage tanks, civil groundworks and associated balance of plant works.

Works are to commence immediately on the design and fabrication of the tanks with a scheduled mobilisation to site in the first quarter of 2025 for anticipated works completion in the third quarter of 2026.

### Eneabba Rare Earths Refinery, WA

Brockman Engineering in conjunction with Tank Industries has been awarded a package of five bulk storage tanks that will form part of the new Eneabba Rare Earths Refinery Project. Upon completion, the new refinery will be Australia's first fully integrated rare earths refinery a key component in Australia's Critical Minerals Strategy.

Brockman and Tank Industries have worked very closely with our client Iluka Rare Earth and their EPCM company Fluor Australia to develop innovative process storage solutions for the plant that meet their specific technical requirements.

Works are to commence immediately on the design and fabrication of the storage tanks with a scheduled mobilisation to site in the third quarter of 2025 for anticipated works completion in the first half of 2026.
