## **Quarterly Activities & Appendix 4C December 2024**

- Biome records \$234k EBITDA for Q2, up 92% vs Q1<sup>1</sup>
- Record cash receipts of \$4.34m in Q2, up 41% vs PCP
- Biome reports record quarterly sales revenue of \$4.61m, up 41% vs PCP
- Biome maintains gross margin above 60% for Q2
- Biome had a cash balance of \$2.59m as at 31 December
- Biome expects to report its first net profit for H1 FY25

Microbiome health company Biome Australia Limited (ASX: BIO) ('Biome' or 'the company') is pleased to provide its Appendix 4C and Activity Report for the guarter ended 31 December 2024.

The company is pleased to report positive EBITDA of \$234k for Q2 - an increase of 92% vs Q1 (\$122k). Quarterly sales revenue reached a new record of \$4.61m, which was \$101k ahead of the Q2 forecast and represents a 41% increase compared to the previous corresponding period (PCP) (Q2 FY24). Cash receipts increased to \$4.34m, up 41% vs PCP, and gross margin was maintained above 60%. 2


Biome has achieved positive EBITDA over four consecutive quarters and expects to report its first net profit in the audited half-year accounts for H1, FY25.

# Biome Australia Managing Director and Founder Blair Vega Norfolk said:

"I am very pleased with the progress in the commercial development of Biome's Activated Probiotics through both Q2 and the first half of FY25. In September we shared Biome's Vision 27 strategic plan. This plan and each of its key elements are well on track. As we continue to grow the Biome business and achieve net profit, we are carefully managing opex and measured investments to drive strong growth in both sales revenue and EBITDA."



## **Quarterly Financial Summary**

Biome reported positive EBITDA of \$234k for the December quarter (Q2FY25). Cash at the end of the quarter was \$2.59m. The company received \$15k from the exercise of options in Q2. Cash flow from operating activities for Q2 was a net inflow of \$107k.

During the quarter, *Biome* completed the transfer payment for its novel probiotic strain, Lactobacillus Plantarum BMB18. Biome announced on 14 November 2024 that it has successfully completed the identification, commercial validation and initial characterisation of BMB18, and that the strain has been lodged with the German culture bank DSMZ. The Company expended \$136k for the development of its intangible assets during the quarter

Business activities expenses consist of sales, advertising and marketing costs of \$315k (a decrease of \$187k from previous quarter \$502k). Payments for inventory and fulfillment increased by \$202k to \$2.28m (previous quarter \$2.08m). Other operating costs reduced by \$15k to \$36k, and research and development increased by \$4k to \$99k vs Sep 2024 quarter. The balance of operating outflows were administration and staff costs totaling \$1.466m, a slight increase of \$34k from the previous quarter.

In Q2, the company received a record \$4.34m in cash receipts from customers (Q2 FY24, \$3.07m), representing an increase of \$1.265m or 41.2% vs PCP. At the end of Q2, the company held \$3.1m in inventory (up from \$2.4m in Q1 FY25), a \$700k increase, representing a wholesale value of \$7.75m vs \$6.0m (Q1 FY25).

The company notes that in Q1, the company paid \$163,726 to Directors of the company in fees, salaries and superannuation payments, as follows:

Biome Australia Trading Pty Ltd ("Biome Trading") a wholly owned subsidiary of The Company has entered into a \$1.5 million secured debt facility ("Facility") with Tradeplus24 (TP24) for working capital purposes to fund future growth.

The current interest rate of the Facility is 11.1384% per annum, with a portion tied to the 30-day bank Bill Swap Rate ("BBSW") bid rate as at midday on the first working day of each month plus a fixed margin of 6.8%. The Facility has a facility fee of 1.8% per annum. The Facility is repayable by 30 June 2025 and is secured by a General Security Agreement over the whole of Biome Trading's assets, a first ranking priority charge over the whole of Biome Trading's receivables (debtor) book and a Deed of Guarantee and Indemnity from the Company, supported by a General Security Agreement over the whole of the assets of the Company as well as a Deed of Subordination over intercompany loans. It is the company's intention to seek a renewal of this facility before the end of FY25 if required.
