We act for Swoop Telecommunications Pty Ltd ACN 109 931 731 (**Swoop Telecommunications**), a wholly-owned subsidiary of Swoop Holdings Limited ACN 009 256 535 (ASX:SWP) (**Swoop**), in relation to its off-market takeover offer (**Offer**) under Chapter 6 of the *Corporations Act 2001*(Cth) (**Corporations Act**) for all if the shares it does not already own in Vonex Limited ACN 063 074 635 (**Vonex**).

Swoop Telecommunications gives notice declaring that:

1. for the purposes of section 650F of the Corporations Act, the Offer as contained in Swoop Telecommunications bidders' statement dated 22 November 2024 and as amended by its supplementary bidder's statement dated 9 December 2024 (**Bidder's Statement**), is free from the following defeating conditions in Section 9 (Offer Conditions) of the Bidder's Statement:
 - a. Section 9.1 (Minimum Acceptance Condition);
 - b. Section 9.2 (No Prescribed Occurrences);
 - c. Section 9.3 (No action by Regulatory Agency materially adversely affecting the Offer);
and
 - d. Section 9.4 (Lender consent for refinancing).

Accordingly, the Offer has now become unconditional;

2. for the purposes of section 630(3) of the **Corporations Act**, the Offer is free from all conditions set out in Section 9 (Offer Conditions) of the Bidder's Statement; and

Swoop Telecommunications' voting power Vonex is 21.42%
