Sale of Campbellfield production facility

Top Shelf International Holdings Ltd (Top Shelf or the Company) announces that it has entered into a binding term sheet for the sale of its plant and equipment at its Campbellfield production facility to Idyll Wine Co Pty Ltd (IDL).

The sale includes all operational and production assets at the Company's Campbellfield facility, inclusive of its canning and bottling lines, brewhouse and distillery but excludes the Company's whisky maturation and warehouse facility at Somerton. In addition, Top Shelf has agreed to the sale of a small portion of its excess bulk whisky inventory to IDL.

The total consideration is \$8m (subject to adjustment for certain historical entitlements of transferring employees) and is to be paid in cash.

Proceeds received from the sale of the operational and production assets and the excess bulk whisky will be applied towards transaction costs and reducing the Company's debts, including the reduction of the Company's outstanding ATO excise liability.

Concurrently, Top Shelf intends to enter into a co-packing arrangement with IDL for the production of its branded products following the completion of the sale.

Completion of the sale is conditional on the negotiation of long-form documentation, and other customary conditions precedent (including obtaining all necessary third party consents or approvals, and novation or assignment of associated leases and contracts).
