December 2024 Quarterly Activity Report

Universal Biosensors, Inc. (ASX:UBI) (UBI) has today released its cash flow report (ASX Appendix 4C) and quarterly activity report for the quarter ended 31 December 2024 (Q4 2024).

UBI is a world leader in electrochemical cell technology and has developed a range of biosensors in human health, animal health and oenology (wine). UBI is also developing and commercializing a range of biosensors in oncology, women's health and fertility, environmental testing in water, all using our patented platform technology and hand-held point-of-use devices.

Key developments during Q4 2024 as reflected in the attached Appendix 4C were:

- Cash outflows from operating activities increased by 11% to \$3.8 million from the previous quarter (Q3 2024 decreased by 11% on Q2) as follows:
 - Research & development spend increased by 16%
 - Product manufacturing and operating costs increased by 16%
 - Administration and corporate costs increased by 16%
 - Interest received decreased by 49%
- Cash outflows from investing activities decreased by 82%.

FINANCIAL UPDATE

Cash and cash equivalents including restricted cash as at 31 December 2024 was \$8.9 million.

Payments of \$91,000 as disclosed in item 6 of the attached Appendix 4C comprised of the non-executive directors' fees, allowances and superannuation.
