QUARTERLY ACTIVITIES AND CASHFLOW REPORT FOR THE PERIOD ENDING 31 DECEMBER 2024

Skylark Minerals Limited (**Skylark** or the **Company**) is pleased to report on its activities for the quarter ended 31 December 2024 (the **Quarter**).

HIGHLIGHTS OF THE QUARTER

- **Transformational Appointment of Experienced Gold Sector Leadership:** Highly credentialed and experienced global gold producer executives, including Mr. Nikolai Zelenski, Mr. Evgeny Tulubenskiy, and Mr. Igor Klimanov, join Skylark to accelerate its next phase of growth.
- **Binding Agreement Reached to Divest Citronen:** Proposed sale of the Citronen Zn-Pb Project further optimises the asset base and provides a fresh foundation for growth.
- **Equity Raise and Share Consolidation Strengthens Balance Sheet and Resets Capital Structure:** Positions the Company to pursue strategic growth initiatives.
- **Exploration Activities Improve Geological Understanding and Confirm Prospectivity:**
 - **Anderson Copper Project, Mt Isa, Queensland:** Field reconnaissance confirmed further work is warranted at the AOI2 magnetic anomaly where two shallow stacked lodes of unknown origin are interpreted to reach within 170m surface.
 - **Narongo Prospect, Captains Flat Project:** December 2024 field activities confirmed the geological characteristics are highly favourable for base metal mineralisation:
 - Prospect area includes multiple historical shafts up to 35 metres in depth, **with copper and zinc soil anomalies that have yet to be drill-tested.**
 - **Several new drill target areas identified**, focusing on zones of known copper, zinc, lead, silver and gold mineralisation.
 - Planning for a follow-up field trip is underway, with **on-field activities scheduled for the second half of 2025.**
- **Dual Track Advancement Strategy Embedded:** alongside new investment in the Company's existing portfolio, a robust acquisition opportunity pipeline was established with a range of priority targets identified.

TRANSFORMATIONAL APPOINTMENT OF EXPERIENCED GOLD SECTOR LEADERSHIP

Transformational Appointment of Mr. Nikolai Zelenski

Mr. Zelenski joins Skylark following a highly successful tenure as CEO of Nordgold, where he led the company from a start-up into a global top-fifteen gold producer, with annual EBITDA exceeding US\$1 billion. During his leadership, he developed a portfolio of eight mines across Russia, Kazakhstan, Burkina Faso, and Guinea, driving rapid growth with a disciplined focus on value creation.

Before Nordgold, Mr. Zelenski honed his expertise in the mining sector as a consultant at McKinsey & Company and as Director of Strategy and Business Development for the Mining Division at PAO Severstal. He holds a Master of Technical Sciences from St. Petersburg State Technical University, a PhD in Molecular Genetics from the University of Texas, and an MBA from Vanderbilt University.

Additional Executive Appointments

The team will further benefit from the experience of former Nordgold executives including:

- Mr. Evgeny Tulubenskiy: Former Nordgold Director of ESG and Chief Legal Officer.
- Mr. Igor Klimanov: Former Nordgold Director of Development.

BINDING AGREEMENT TO DIVEST CITRONEN

Sale Enhances Asset Base and Provides a Fresh Foundation for Growth

On 17 December 2024, the Company announced it had entered into a binding agreement to divest 100% of its Citronen Zn-Pb Project (**Citronen Project**) through the sale of its wholly owned subsidiary, Ironbark A/S, to Almeera Ventures Limited, based in Dubai (the **Transaction**). This divestment aligns with Skylark's strategic focus on value creation through gold and precious metal opportunities, alongside advancing its existing base metal portfolio.

Key Commercial Terms:

Gross Consideration: A\$1.4 million, payable in stage instalments:

- A\$50,000 non-refundable deposit (received).
- A\$950,000 on completion.
- A\$250,000 three months after completion.
- A\$150,000 six months after completion.

Conditions Precedent:

- Completion of due diligence to the buyer's satisfaction within four months.
- Approval by the Government of Greenland for an initial four-year licence term.
- Receipt of all required regulatory and third-party approvals.
- Buyer depositing approximately DKK 4.2 million into the Company's escrow account to cover the potential rehabilitation costs for the Citronen Project exploration camp.

Completion is expected to occur in Q2 CY25, following a statutory three-month consultation period overseen by the Government of Greenland.

BALANCE SHEET STRENGTHENING AND CAPITAL STRUCTURE RESET

A\$10 Million Placement and Share Consolidation

The Company raised A\$10 million in new funding (before costs) through the issuance of 50 million fully paid ordinary shares (**Placement Shares**) at A\$0.20 per Placement Share (on a post-Consolidation basis), together with two free unlisted attaching options for every three Placement Shares subscribed for (**Placement Options**).

All Directors participated in the Placement, including incoming Directors, Mr. Segman (elected at the 2024 AGM), and Mr. Zelenski (elected at the EGM held in December 2024).

Placement Options terms:

- Tranche 1: 50% exercisable at A\$0.30, expiring 3 July 2026.
- Tranche 2: 50% exercisable at A\$0.40, expiring 3 January 2028.

The Placement Shares rank pari-passu with the existing fully paid ordinary shares in the Company.

EXPLORATION ACTIVITIES CONFIRM PROSPECTIVITY

Anderson Copper Project, Mt Isa, Queensland

October 2024 Field Reconnaissance

Field reconnaissance conducted at the Anderson Copper Project in October 2024 aimed to assess the geology and surface expression of the targets identified by Resource Potentials in an independent geophysical interpretation. The field trip confirmed the surface geology to be ironstones – hematitic in the near surface but possibly magnetite at depth, which are outcropping and occur as stratiform layers. Hematitic ironstones are considered to be excellent host rocks for copper or copper+gold mineralisation.

Narongo Prospect, Captains Flat Project

December 2024 Field Reconnaissance

Field reconnaissance conducted at the Captains Flat Project in December 2024 focused on the Narongo Prospect. This area, 13km south of the historic Lake George Mine, shows promising geological continuity with historic production of copper, zinc, lead, silver, and gold. For sampling results please refer to the ASX announcement released post quarter end on 13 January 2025.

While anomalies were weak overall, the area's geology suggests further exploration is warranted. Follow-up field activities are scheduled for the second half of 2025.

Change of Company Name to Skylark Minerals

The Company began trading as Skylark Minerals Ltd on 7 January 2025.
