As announced subsequent to quarter end, \$250,000 of loan notes were repaid on 11 January 2025, and ADX entered into deeds of variation with the remaining Loan Note holders in relation to 25 Loan Notes of A\$50,000 each totalling A\$1.25 million as follows:		
<ul style="list-style-type: none"> - Interest payable at 8% pa on \$200,000 of the loans; - Interest payable at 12% on \$1,050,000 of the loans and - Repayable by 31 March 2026.
