### **Extraordinary General Meeting Results**

One Managed Investment Funds Limited (**Responsible Entity**), as the responsible entity of Fat Prophet Global Property Fund (**FPP**), announces the results of the extraordinary general meeting (**Meeting**) held today, at 2:00pm (Sydney time) on 29 January 2025 at Level 16, Governor Macquarie Tower, 1 Farrer Place, Sydney NSW 2000 (**Meeting**).

The Meeting was convened pursuant to a requisition received by the Responsible Entity under section 252B(1) of the *Corporations Act 2001* (**Corporations Act**), requesting the Responsible Entity to call a members' meeting to consider an extraordinary resolution (**Resolution**) to wind up FPP pursuant to section 601NB of the Corporations Act.

The Resolution was voted on a poll and approved by members. The results of the Meeting are shown in the attached report.

The Responsible Entity intends to now commence a process to wind up FPP. The Responsible Entity intends to provide material updates to the market in accordance with its obligations under ASX Listing Rule 3.1.

The Responsible Entity has commenced engagement with ASX with respect to the removal of FPP from the Official List of ASX following completion of the winding up process.
