QUARTERLY ACTIVITIES UPDATE AND APPENDIX 4C

Period Ending 31 December 2024

Orbital Corporation Ltd ('Orbital UAV', 'the Company') presents its quarterly activities report for the period ended 31 December 2024.

PRODUCTION AND SHIPPING

Orbital UAV is now in production for four engine lines servicing key clients in the USA, Singapore, Vietnam and India. A total of 29 engines were delivered in the six-month period, with a further 39 engines forecast for the second half of the 2025 financial year.

2 engines were delivered to a new Indian customer during the first half with a further 4 engines scheduled for delivery in the second half.

As detailed in the operating cashflows described in the Appendix 4C, \$1.9 million of revenue was received from customers in Q2 with a further \$1.6 million of cash receipts in respect of engines already delivered to be received in Q3.

ENGINEERING PROGRAMS

In addition to the 4 revenue generating engineering programs, Orbital is continuing the development, design and prototyping of a larger capacity internal combustion engine to achieve heavier payload delivery and enhanced power to weight specifications. Orbital has now completed the initial detailed design drawings, has developed a supply chain & sourcing strategy and early prototype builds are underway to enable commencement of a test program to measure engine performance outcomes during Q4.

OTHER INCOMES & DEBT

Following grant approval in December 2024, Orbital UAV has achieved full repayment of the legacy WA government loan, taking Orbital into a debt free position at 31 December 2024. In addition, R&D Grant funds of \$1,896,000 were received in early January 2025.
