Answer: No. NVU anticipates it will receive cash from sales over the coming quarter which shall improve operating cash flow.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Subsequent to the quarter, the Company has received an additional \$500k, with a further \$410k expected to be received imminently (**\$910k in total**), relating to Placements announced on the ASX 4 June 2024 and 15 October 2024. Both placements were approved by shareholders at the NVU Shareholder General Meeting in December 2024. The company will continue to monitor expenses and assess future funding needs to support its planned operations.
