Answer: Yes. Currently in voluntary suspension pending finalisation of capital raise of between \$6m - \$8.6m. Finalised working capital facility of \$1.1m from Kestrel Structure Capital Fund beginning of October 2024. The facility is a \$1.1m debt facility, secured (second ranking) subject to shareholder approval. Interest is bank base rate + 10%.
