Production Milestone at Chatree Gold Mine

Kingsgate Consolidated Limited ASX:KCN (“Kingsgate” or the “Company”) is pleased to announce that last week marked the one hundredth gold pour to occur at the Chatree Gold Mine since the restart in March 2023.

The doré bars from the 100th gold pour will be refined by Kingsgate’s refining partner, Precious Metal Refining Company Limited (“PMR”), who has refined all gold and silver from Chatree since operations restarted.

Further, January 2025 saw the continued uplift in head grade to an average of 0.57 g/t gold, up from 0.51 g/t gold for the December 2024 quarter. In addition, volume of ore mined continues to exceed expectations, with January’s results above forecast.
