GENERATION DEVELOPMENT GROUP LIMITED - REQUEST FOR TRADING HALT


Generation Development Group Limited (ASX:GDG) requests an immediate trading halt in respect of its shares prior to the commencement of trading on Monday, 10 February 2025.
