

## TAKEOVER UPDATE OFFER DECLARED FREE FROM CONDITIONS

Astral Resources NL (ASX:AAR) (**Astral**) refers to its off market takeover bid to acquire all of the ordinary shares of Maximus Resources Limited (ASX:MXR) (**Maximus**) (**Offer**) it does not already own on the basis of one (1) Astral Share for every two (2) Maximus Shares held pursuant to the Bidder's Statement dated 3 February 2025 (**Bidder's Statement**).

### Offer now unconditional

Astral advises that it has obtained a Relevant Interest in at least 50.1% of all Maximus Shares and therefore declares the Offer unconditional and free from all Conditions.

- (c) Maximus Shareholders who validly accepted the Offer before it was declared unconditional (i.e. before the date of this announcement) will be issued their Astral Shares by no later than Monday 10 March 2025; and
- (d) all other Maximus Shareholders who have yet to validly accept the Offer will be issued their Astral Shares within 10 Business Days of their acceptance being processed in accordance with the terms of the Offer.
