Loss of Government contract with Australian Electoral Commission

AUCyber Limited (ASX: CYB) (“AUCyber” or “the Company”) advises that it has been notified by the Australian Electoral Commission (AEC) of their decision to terminate its agreement for cybersecurity monitoring operations (Agreement) with CYB.

Initially entered into in 2022, the Agreement was extended in June 2024 when the AEC exercised a 12-month option, extending the engagement through to 30 June 2025. However, under the terms of the Agreement, the AEC retains the right to terminate the Agreement before the expiration of the extension period.

Monthly revenue will decrease by \$60,000 as a result of the termination. The termination will take effect as of 28 February 2025.

AUCyber remains committed to delivering high-quality cybersecurity services and will continue pursuing new opportunities across both government and private sector engagements.
