

**20 March 2025****UNDERWRITTEN SHARE PURCHASE PLAN**

Hillgrove Resources Limited (ASX: HGO) (**Hillgrove** or **Company**) announced on Wednesday, 5 March 2025, a combined equity raising of up to \$16 million at a price of \$0.035 per new share, comprising:

- a \$13.0 million placement to institutional and sophisticated investors (“Placement”); and
- a Share Purchase Plan (“SPP”) to raise up to \$3.0 million, in which existing eligible shareholders will be offered the opportunity to participate.

The SPP is currently being conducted and is scheduled to close on Friday, 28 March 2025. Hillgrove is pleased to advise that Blue Ocean Equities Pty Ltd (ACN 53 151 186 935) (“Blue Ocean”) have agreed to underwrite the SPP up to an amount of \$2,200,000. With valid applications for shares pursuant to the SPP received to date, the underwriting of the SPP enables Hillgrove to have certainty of receiving the full \$3.0 million from the SPP and brings gross proceeds from the Placement and SPP to an aggregate of \$16 million.

Blue Ocean were a Joint Lead Manager for the Placement and have entered into an underwriting agreement with Hillgrove (“Agreement”). The issue of any underwritten SPP shares pursuant to the Agreement will be subject to the approval of the Company’s shareholders at the Annual General Meeting scheduled to be held on Tuesday, 6 May 2025. In accordance with the Agreement, the Company has agreed to pay Blue Ocean an underwriting fee of 5.0% of the amount of the SPP underwritten through the Agreement.
