Livium signs exclusive battery recycling agreement with Hilti

HIGHLIGHTS

- Livium has signed an exclusive recycling agreement with Hilti, a leading power tool manufacturer globally
- In addition to the B-Cycle program rebates, Livium will receive fees from Hilti for providing collection, sorting, and recycling services to Hilti in Australia for their returned Fleet Management batteries
- The agreement commences on 1st April 2025, for an initial term of 3 years and further diversifies recycling material supply chains to complement existing agreements
- The agreement expands Livium's range of channels for end-of-life Lithium-ion batteries

Livium Ltd (ASX: LIT) ("**Livium**" or the "**Company**") is pleased to announce that its wholly owned subsidiary Envirostream Australia Pty Ltd ("**Envirostream**"), a leader within the Australian battery recycling industry has signed an exclusive recycling agreement ("**Agreement**") with Hilti (Aust.) Pty Ltd ("**Hilti**").

Under the Agreement, Livium will exclusively recycle Hilti Fleet Management batteries. Hilti Fleet Management provides businesses with a service-based power tool solution, offering fixed fees for tool usage, maintenance, repairs, and management, instead of traditional tool ownership. Livium and Hilti are contributing members of the Battery Stewardship Council's (BSC) B-Cycle program. Under the Agreement Livium will provide collection, sorting, and recycling services to Hilti. In return, Livium will receive a service fee from Hilti and rebates from the BSC for eligible batteries.

Livium plays a vital role in the success of the BSC's B-Cycle program, serving as a key partner in driving responsible battery recycling and resource recovery. Through its expertise and nationwide collection network, Livium has helped significantly increase battery diversion from landfill, improve recycling efficiency, and supported the responsible disposal of hazardous materials.

The Agreement commences on 1st April 2025, with an initial 3-year term and an optional term of 1-year. The Agreement, whilst exclusive, has no minimum volumes during the Agreement term and, as a result, Livium is not in a position to quantify the economic impact of the Agreement at this stage.

This Agreement aligns with Livium's focus to secure exclusive battery recycling contracts and diversify its end-of-life battery sources. It also ensures a stable and scalable source of end-of-life batteries from the power tool sector, alongside other industries such as e-mobility and energy storage.

Comment from Hilti Codes & Approvals (Firestop) / WHS Manager, Martin Stirling

"Hilti has laid the foundations for a functioning circular economy in the power tool market segment through its Fleet Management leasing service. Viable spare parts are harvested from collected Fleet Management tools and the balance of materials are recycled.

"Now, to complete the tool end-of-life process, all ex-Fleet Li-Ion batteries are responsibly recycled onshore in Australia through our partner Envirostream."
