SciDev secures first contract in US for PFAS remediation on US Department of Defense sites

Highlights

- ▶ SciDev secures first contract in the US with Halff to treat investigation derived waste containing PFAS 'forever chemicals' at US Department of Defense installations.
- ▶ Contract value of A\$396K for SciDev to remediate up to 190,000 litres of PFAS impacted water across four installations in the Southern United States.
- ▶ Opens a market for PFAS treatment and remediation across 55,000 currently identified sites in the US valued at USD \$220 billion
- ▶ Contract marks a major milestone in SciDev's expansion into the US water technology market.

SciDev Ltd (ASX: SDV) ('**SciDev**' or '**the Company**') has secured a contract with US consulting firm Halff for the treatment of PFAS-impacted investigation derived waste on US Department of Defense (DoD) sites. This is SciDev's first contract in the US for PFAS remediation.

Under the A\$396K contract, SciDev will treat up to 190,000 litres of PFAS contaminated water across four DoD installation in the southern United States.

PFAS contamination on DoD sites remains a critical issue, with legacy firefighting foams polluting groundwater near military bases. The DoD has identified elevated PFAS contamination across 80% of US military bases

SciDev CEO Seán Halpin said, "I am thrilled our first contract in the United States for PFAS treatment is supporting the US Department of Defense. Assisting the DoD with their PFAS concerns is a strong validation of our world-leading remediation technology and highlights the growing global demand for sustainable, effective water treatment solutions.

"The partnership with Halff represents a significant commercial opportunity as we continue to scale our presence in the US, allowing us to take advantage of the broader national market for PFAS remediation currently valued at USD\$220 billion.
