

## Drill planning well advanced at the Carter Uranium Project, Montana, USA

Drilling will focus on high-priority targets generated through the compilation and systematic review of existing data.*

With strong tailwinds supporting US uranium development, Recharge remains well-funded to execute its exploration strategy and is excited about the potential of this significant uranium asset.”*

### Senior Management Site Visit

Recharge's senior management team, including Managing Director Felicity Repacholi, has just returned from a site visit to Montana. The visit included meetings with key stakeholders, and assessments of project infrastructure and logistics to facilitate the next phase of exploration.

As part of its commitment to responsible exploration and development, the Company has been engaging with local ranch owners and community stakeholders to ensure a collaborative approach to land access and project advancement. These discussions have been well received and continue to progress positively.

## Environmental Permitting Underway

Recharge has commenced the permitting process necessary for exploration drilling. The Company is working closely with an experienced consulting group to ensure compliance with environmental and land use requirements, laying the groundwork for upcoming drill programs.

## Drill Planning Advancing

The Company is making significant progress in planning its initial drill program at the Carter Uranium Project. Data compilation, geological review, and target generation are in final stages. Drilling will focus on high-priority targets identified from historical data and recent evaluations.

Recharge remains well-funded to execute its exploration strategy at Carter and is excited about the potential of this significant uranium asset.

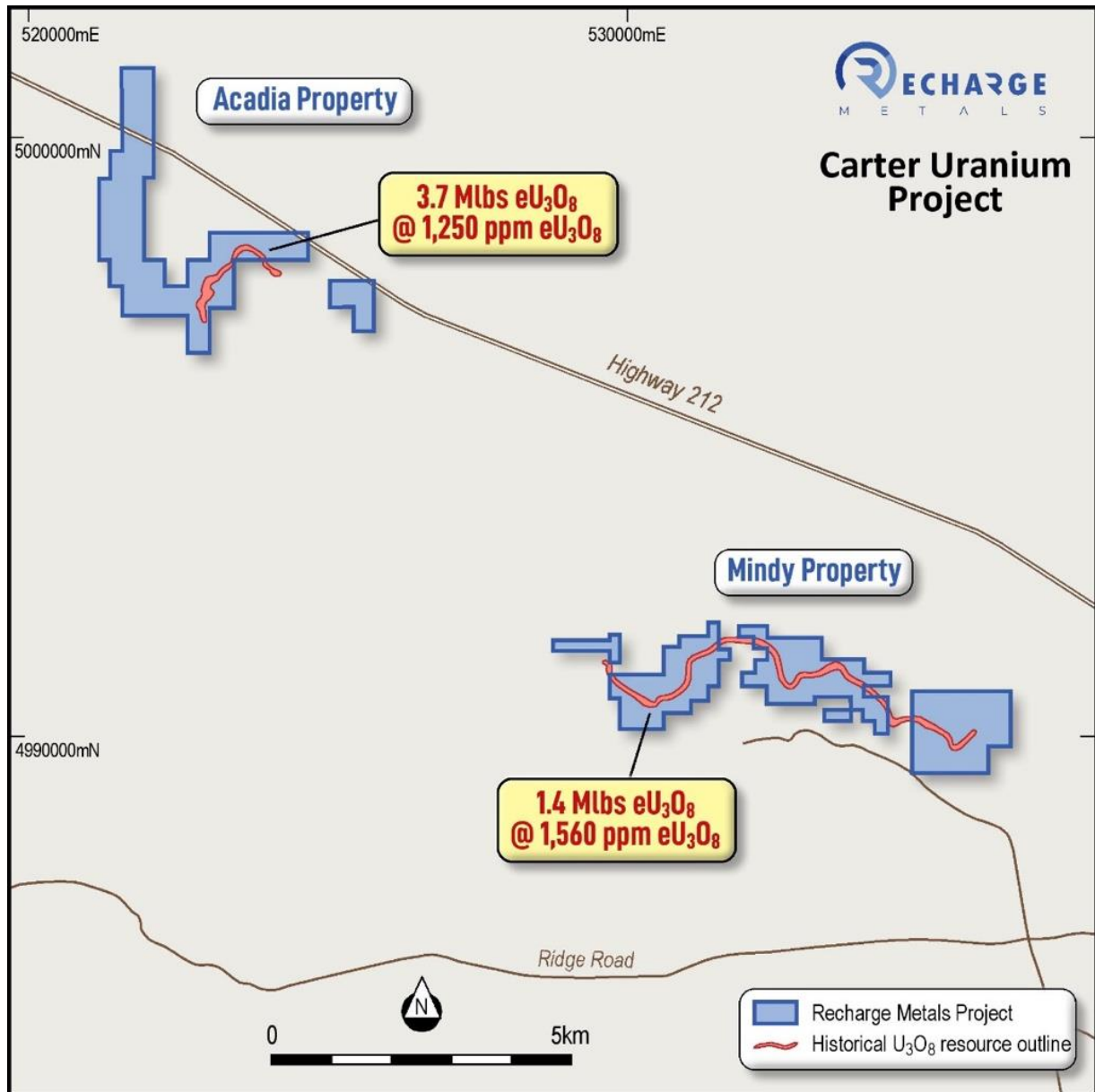


Figure 1: Carter Uranium Project location and historical resources

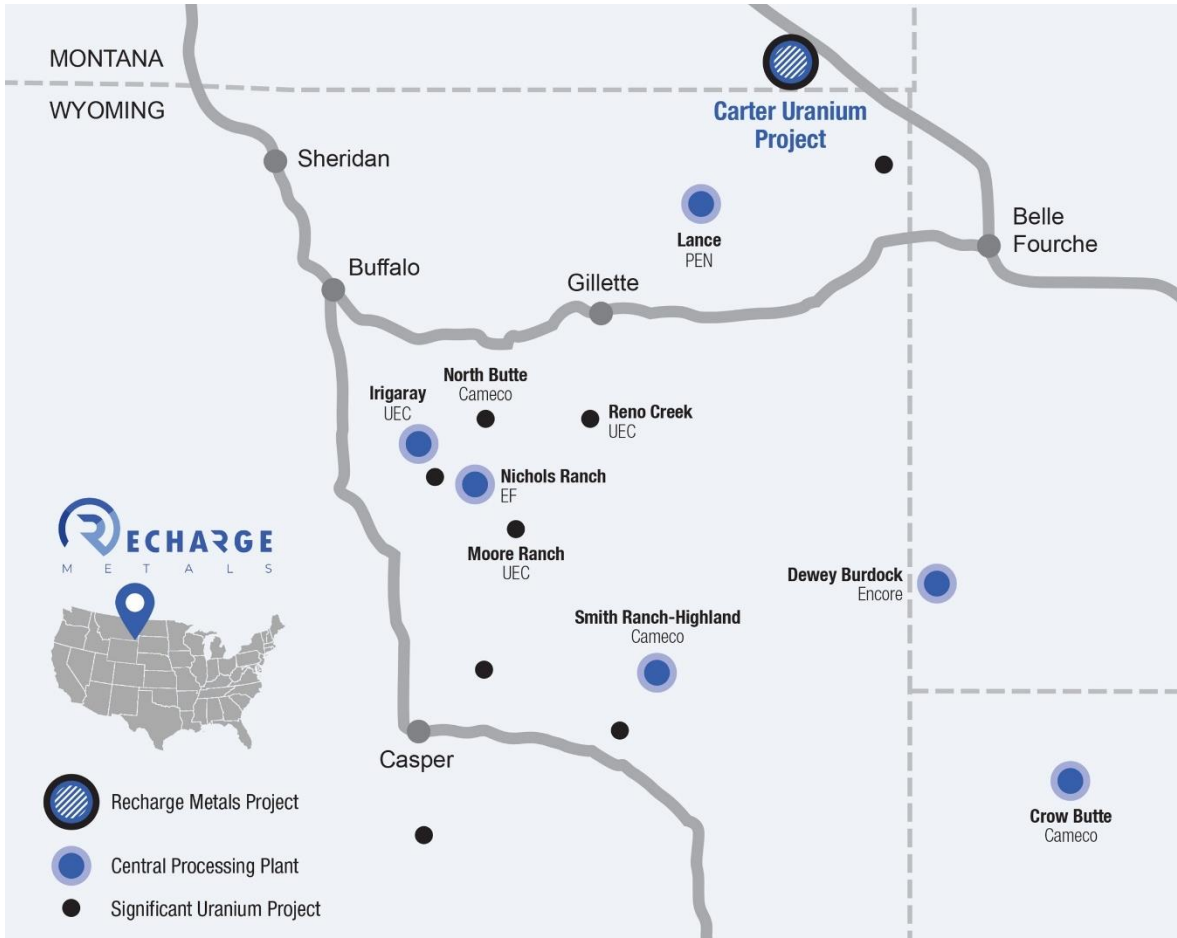


Figure 2: Carter Uranium Project with notable uranium facilities in the region
