Aurum hits 83m at 4.87 g/t gold from 106m at 1.59Moz Boundiali Project

Aurum Resources (ASX: AUE) reports further shallow, high-grade gold intercepts at **BDT1**, part of its 1.59Moz Boundiali Gold Project in Côte d'Ivoire, including a **tenement and project best result** to date in DSDD0148.

Highlights

- Exploration diamond drilling at **BDT1** deposit (five holes for 1,503.45m) and **BDT3** prospect (four holes for 713.80m) on Boundiali's **BD** tenement returns shallow, high-grade gold hits¹, with intercepts including:

- These results demonstrate the **emerging potential** and **continued upside** of the Boundiali project, where mineralisation **remains open along strike and at depth**.
- All eight of Aurum's self-owned diamond rigs **continue to drill** at Boundiali with **100,000m** targeted in CY2025; assay results pending.
- **Two MRE updates** planned in **CY2025** to grow the maiden **1.59Moz Boundiali Mineral Resource Estimate**².
- Aurum has commenced work on a **Boundiali Pre-Feasibility Study**, due for completion by end of CY2025.
- **Aurum is well-funded**³ for continued exploration success at its Boundiali and Napié projects, which host a **combined 2.5Moz gold**.

Aurum's Managing Director Dr. Caigen Wang said: "Our diamond drilling at Boundiali continues to deliver high impact results, with DSDD0148 hitting **83m @ 4.87 g/t Au** (equalling **404.1** gold gram metres) from 106m at **BDT1**. This is a project and tenement best result and comes from drilling designed to deliver Indicated Mineral Resources at **BDT1**. We knew there were high grades in among the thick zones of gold mineralisation at **BDT1**, with a previous result of **12.22m @ 14.56 g/t Au** from 275m in DSDD0051, and latest results further validate this and will help us better understand and target these plunging high-grade shoots with drilling; remembering that gold mineralisation is still open at **BDT1**."

Aurum has commenced 100,000m of planned diamond drilling at Boundiali in 2025. These and other drill results will be incorporated into two MRE updates. The first update, expected late in the first half of 2025, will include these recent high-grade intercepts and build upon the current **1.59Moz Boundiali MRE**. A second update, planned for late in CY25, will incorporate results from planned drilling at the **BD, BM, and BST** deposits, as well as numerous untested gold-in-soil anomalies. Aurum's use of its own drill rigs provides for cost-effective and accelerated exploration, underpinning our

objective of significant resource growth at Boundiali in 2025 and beyond, ultimately contributing to a Pre-Feasibility Study expected by year-end.

At our recently acquired Napié project, a 30,000m diamond drilling program is planned for 2025, targeting expansion of the current **0.87Moz MRE**⁴. This program will begin pending renewal of the Napié exploration licence, with an updated MRE anticipated by year-end.

With a combined **2.5Moz of gold** across Boundiali and Napié, and substantial drilling programs planned for both projects, Aurum is well-positioned for significant resource growth and further value creation in 2025.”

BD - Latest Drill Results

Aurum is reporting new assay results from drilling at **BDT1** deposit (five holes for 1,503.45m) and **BDT3** prospect (four holes for 713.80m) on Boundiali’s **BD** tenement, where Aurum holds an 80% project interest⁵. Best assay results for the new drilling includes⁶:

DSDD0148 (drilled at BDT1) represents a **tenement and project best** to date, as measured on a gold gram x metres basis (eg: 83m x 4.87g/t Au = 404 gold gram metres). This new result is in addition to diamond holes drilled and reported⁷ by Aurum at **BD**, which include:

- **12.22m @ 14.56 g/t Au** from 275m inc. **1m @ 163.42 g/t Au** (DSDD0051)

BDT1 gold deposit and **BDT3** gold prospect are located within a 13km by 3km gold mineralised corridor which remains underexplored, and more drilling is required (and planned) to systematically test this prospective corridor. Drilling is ongoing at both **BDT1** and **BDT3** with more assays pending. True widths for these shallow wide and high-grade gold intercepts are estimated at about 70% - 80% of reported downhole lengths.

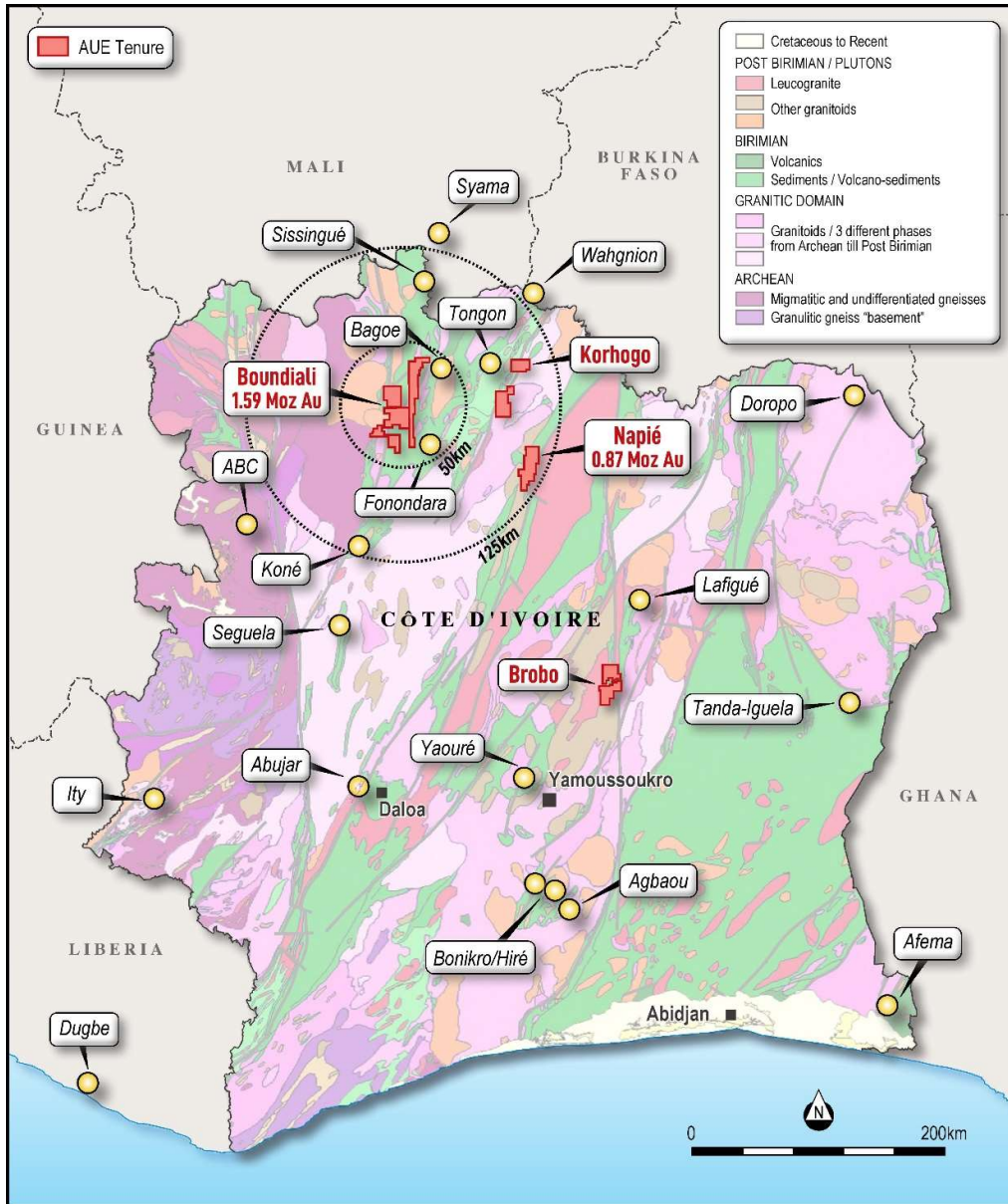


Figure 1: Location of Aurum's projects in Côte d'Ivoire

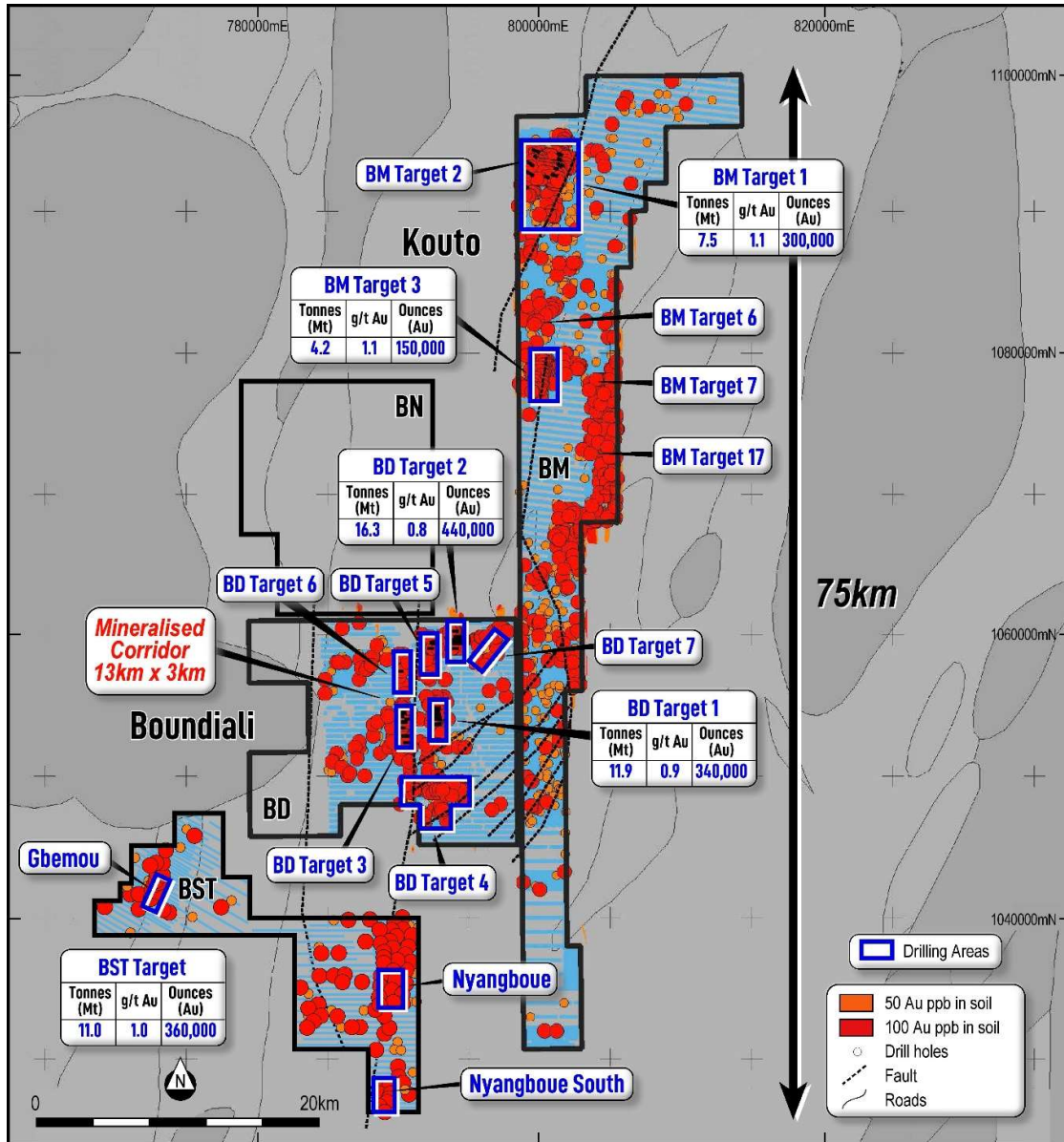


Figure 2: Aurum's Boundiali Gold Project

Details of drill collar location and assay results for the new drilling being reported at **BDT1** and **BDT3** can be found in **Table 1** and **Table 2** respectively. Plans showing location of the Boundiali Gold Project and the assay results are presented in figures below (general locations in **Figure 1** and **Figure 2** and a detailed plan in

Figure 3). A cross section showing the latest drill results is presented in **Figure 4**.

Gold mineralisation remains open along strike and at depth on all deposits and prospects. Aurum intends to drill 100,000m drilling at Boundiali in CY2025 and is planning further work to follow up these results.

Boundiali – 100,000m drill program

Aurum has commenced an extensive 100,000m diamond drilling program at its 1.59Moz Boundiali Gold Project in northern Côte d'Ivoire to be completed in 2025⁸. The program has multiple aims:

- Increase the size and confidence of current resources at BST, BD, and BM (40,000m),
- Advance known prospects (30,000m) for incorporation into two planned MRE updates in 2025.
- Target new prospects identified through soil anomalies and geological mapping to drive resource growth into 2026 (30,000m).

Next Steps:

- **Aggressive cost-effective exploration at Boundiali:** Aurum is committed to a large-scale exploration program at Boundiali. This includes:
 - **100,000m diamond drilling:** Up to eight diamond drill rigs will complete 100,000m of drilling at Boundiali in CY2025.
 - **Resource expansion:** Drilling aims to expand the known resources at the BST, BD, and BM deposits.
 - **New discoveries:** Exploration and scout drilling is planned on BD, BM and BST tenements to test new targets and create a pipeline of new discoveries to flow into resource growth.
- **Resource updates:** Aurum plans to deliver two MRE updates for Boundiali in CY2025.
- **Napié project development:** A 30,000m diamond drilling program is planned for the Napié project in CY2025 to expand the existing 0.87Moz resource. An updated MRE for Napié is expected by year-end.
- **Pre-Feasibility Study:** Aurum is working towards completing a PFS for the Boundiali Gold Project by the end of CY2025. This will provide an evaluation of the project's economics and technical feasibility.

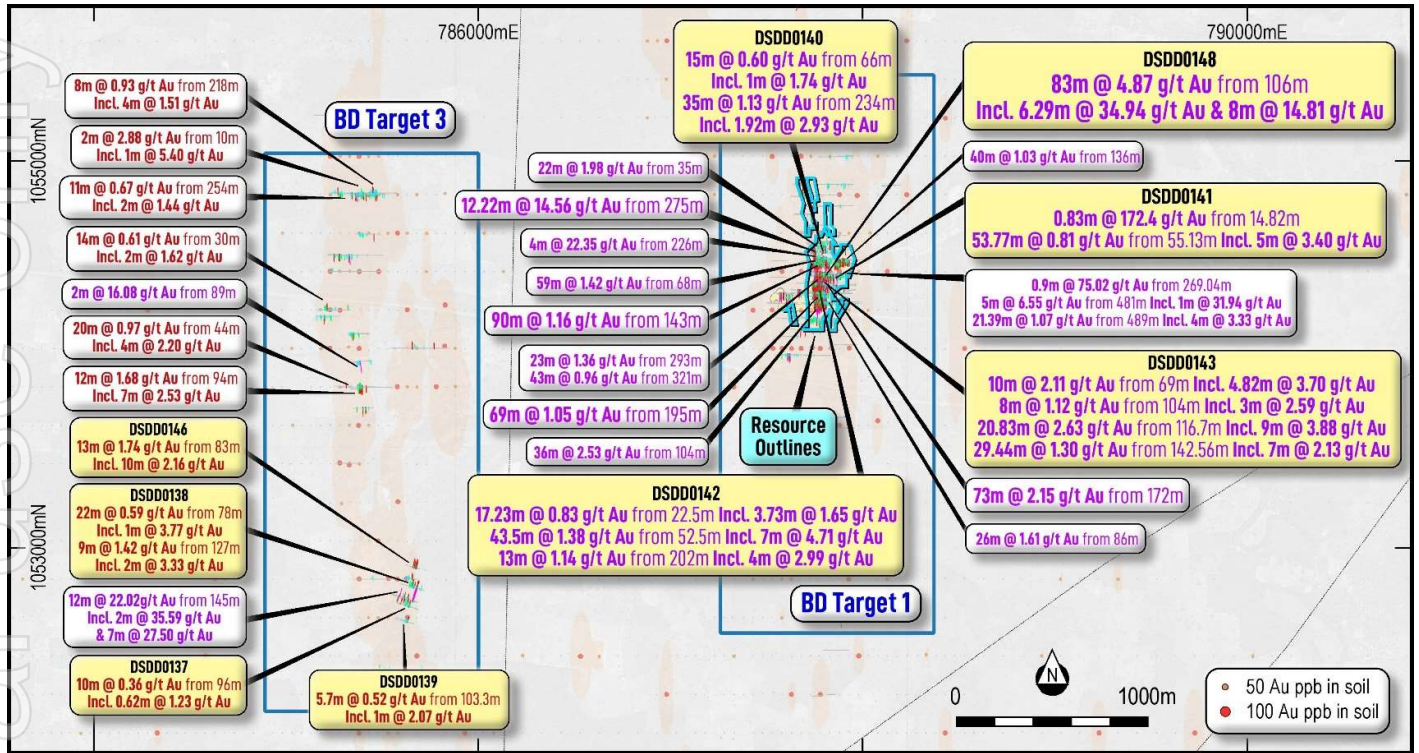


Figure 3: BD tenement plan view showing new significant drilling results (yellow) at BD Target 1 and 3

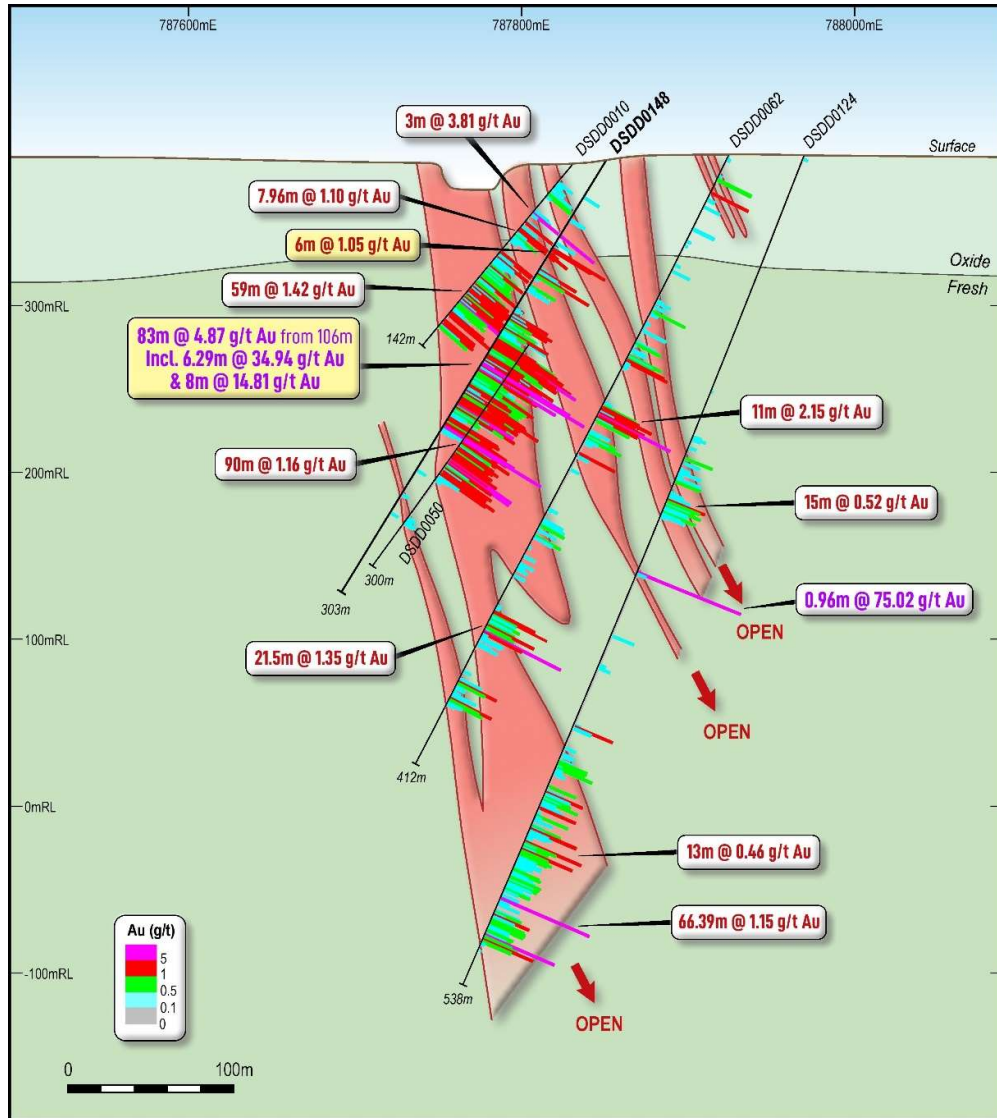


Figure 4: Oblique Cross Section looking northeast (+/-25m) showing new drill results DSD0148 – BD Target 1

Boundiali Gold Project (1.6Moz)

The flagship 1.6Moz Boundiali Gold Project is comprised of four neighbouring exploration tenements and is located within the same greenstone belt as Resolute's large Syama (11.5Moz) gold mine and Perseus' Sissingue (1.4 Moz) gold mine to the north and Montage Gold's 4.5Moz Koné project located to the south.
