Business Update

JCURVE SOLUTIONS LIMITED (ASX: JCS) (Jcurve), the company that helps businesses grow, provides the following update.

The Half Year Accounts for the period ended 31 December 2024 released to market on 28 February 2025 included a note relating to going concern and commission rates. Since releasing the accounts, we are pleased to advise of an increase in the commission rates that we will receive for existing customers for the January to June 2025 period (2HFY25). The confirmed change in commission rate is forecasted to increase revenue and gross margin by between \$450,000 - \$500,000 for the period 2HFY25. This increase will also improve cash inflows by the same amount over the forecast period referred to in the going concern note.

In addition to the positive financial impact for FY25, this sets the business up for further top line revenue and margin improvements from existing customers in future years and as discussed in our CEO's business update dated 24 February 2025.
