REQUEST FOR TRADING HALT

Pursuant to Listing Rule 17.1, Cauldron Energy Limited (the **Company**) (ASX: CXU) hereby requests an immediate trading halt be placed on its securities from the commencement of trading today.

In accordance with Listing Rule 17.1, and in support of this request, the Company advises:

- a) The trading halt is requested pending an announcement by the Company with respect to a maiden mineral resource estimate for the Manyingee South deposit (**Announcement**);
- b) The Company requests that the trading halt remain in place until the earlier of such time as it makes the Announcement to the market, or the commencement of normal trading on Thursday, 3 April 2025; and
- c) The Company anticipates making the Announcement prior to the commencement of normal trading on Thursday, 3 April 2025.
- d) The Company is not aware of any reason why the trading halt should not be granted, or of any other information necessary to inform the market about the trading halt.
