SSR Mining Inc. (ASX: SSR) – Request for suspension of securities under Listing Rule 17.2 and termination of quotation and removal from the official list under Listing Rules 17.10 and 17.11

SSR Mining Inc. (**SSR**) refers to its announcement dated 3 March 2025 that the Australian Securities Exchange (**ASX**) agreed to SSR's request for SSR to be removed from the official list pursuant to ASX Listing Rule 17.11 (**Announcement**) and SSR's letter to the General Manager of ASX Listings Compliance requesting removal from the ASX Official List dated 12 February 2025 (**Removal Letter**).

Request for suspension

SSR requests the suspension from official quotation of SSR's CHESS Depository Interests (**CDIs**), effective from the close of trading on Friday 4 April 2025 (**Suspension**) in accordance with the delisting timetable contained in the Announcement.

Pursuant to Listing Rule 17.2, SSR provides the following information:

- 1 SSR requests the Suspension to enable the settlement of any CDI trades before SSR is officially delisted from the ASX. SSR further refers to the reasons of the delisting set out in the Removal Letter.
- 2 SSR requests the Suspension for a period of two (2) business days (from close of trading on Friday 4 April 2025 until close of trading on Tuesday 8 April 2025), at which point SSR expects to be removed from the official list of the ASX.
- 3 SSR expects the event that will end the Suspension is SSR's removal from the official list which is expected to take effect as at close of trading on Tuesday 8 April 2025 in accordance with the delisting timetable contained in the Announcement.
- 4 SSR is not aware of any reason why the CDIs should not be suspended.
- 5 SSR is not aware of any other information necessary to inform the market about the suspension.

Request for termination of quotation and removal from the official list

Under Listing Rules 17.10 and 17.11, SSR requests the termination of the official quotation of CDIs on the ASX and that SSR be removed from the official list of the ASX with immediate effect upon close of trading on Tuesday 8 April 2025 (**Removal**).

SSR's request for the Removal is in accordance with the delisting timetable contained in the Announcement.

SSR is not aware of any reason why SSR should not be removed from the official list of the ASX and is not aware of any other information necessary to inform the market about the Removal.
