Chief of Staff & Deputy Chief Innovation Officer appointment

Throughout the course of his career, Zubin has gained substantial experience in mergers and acquisitions, integration of acquired businesses, building high performance teams, growing and scaling businesses and delivering global product capabilities and complex technology solutions. He holds a Bachelor of Information Technology from UTS (a scholarship degree with Distinction).
