

## **Scheme of Arrangement Becomes legally Effective and Suspension of Trading on ASX**

**16 April 2025**

SG Fleet Group Limited (ASX: SGF) (**SG Fleet**) refers to its announcement made on Tuesday, 15 April 2025 and confirms that it has lodged with the Australian Securities and Investments Commission (**ASIC**) an office copy of the orders made by the Supreme Court of New South Wales (**Court**) approving the scheme of arrangement under which Westmann Bidco Pty Limited, an entity owned and controlled by funds managed or advised by Pacific Equity Partners Pty Limited, will acquire all of the shares in SG Fleet (**Scheme**).

Unless otherwise indicated, capitalised terms used in this announcement have the meaning given to them in the Scheme Booklet in relation to the Scheme dated 21 February 2025.

### **Lodgement of Court Orders and Suspension of Trading**

An office copy of the Court orders lodged with ASIC is attached to this Announcement as **Annexure A**.

The Scheme is now legally effective, and it is expected that trading in SG Fleet Shares on the ASX will be suspended from the close of trading today (Wednesday, 16 April 2025).

### **Payment of Scheme Consideration**

It is expected that implementation of the Scheme will occur on Wednesday, 30 April 2025 and SG Fleet Shareholders will be issued the Scheme Consideration on that date in respect of each SG Fleet Share held on the Scheme Record Date (being 7.00pm (Sydney time) on Wednesday, 23 April 2025) (**Scheme Share**).

SG Fleet Shareholders (other than Relevant Management Shareholders to the extent they have made a valid Election to receive the Scheme Consideration in the form of Scrip Consideration in respect of some or all of their Scheme Shares, as described below) will receive an amount of \$3.50 in cash per SG Fleet Share.

Relevant Management Shareholders who have made valid Elections to receive the Scheme Consideration in the form of Scrip Consideration in respect of some or all of their Scheme Shares will receive 3.5 Topco Shares for each of those Scheme Shares, subject to rounding.

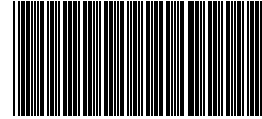
