Quarterly Activities Report**Q4 FY25 headlines:**

- **Wingara reports a 31 March 2025 cash position of \$648k;**

Wingara AG Limited (ASX: WNR), is pleased to provide its 31 March 2025 quarter's activities report alongside its Appendix 4C (Quarterly Cashflow Report) for the twelve months ended 31 March 2025 (Q4 FY25).

As previously announced, Wingara ceased its processing operations on 14 November 2024 and further announced the sale, subject to shareholder approval, of its main machinery and auxiliary components on 27 February 2025. During the quarter Wingara received \$500,000 plus GST (from the agreed sale price of \$750,000 plus GST). In line with the shutdown of processing, Wingara has incurred restructuring costs associated with the reduction in required workforce and cessation of activities at Epsom. Wingara continues to maintain storage services and this will wind down during the middle of the year as the machine is dismantled and transferred to the new owners. Site obligations including ongoing property lease payments will continue to occur until the lease expires in February 2026.

Current cash and cash equivalents as at 31 March 2025 were \$648k with a focus on cost control and managing its remaining liabilities and obligations.

Subsequent events

On 9 April 2025 shareholders approved the sale of the main undertaking at the Wingara EGM. Accordingly, the sale of the Epsom hay press and associated equipment has now been completed.

The final instalment payment for the hay press amounting to \$250,000 plus GST was received in April 2025.

In accordance with ASX Listing Rule 4.7C.3, payments to related parties and their associates outlined in the Company's Appendix 4C for the quarter relate to fees and salaries paid to Directors.
