## Bruins Well on Track for 2Q2025 Production and First Sales Completion Operations Underway

Perth, Western Australia – Brookside Energy Limited (ASX: BRK) (OTC Pink: RDFEF) (Brookside or the Company) has mobilised completion crews and equipment with operations now underway at the Bruins Well, located within its SWISH Play acreage in the Anadarko Basin, Oklahoma. First production and sales remain on track for the second quarter. The Bruins Well is Brookside’s ninth operated well in the SWISH Play and a key part of the Company’s 2025 strategy — targeting disciplined inventory growth, operational excellence, and near-term cash flow generation.

### Current Operations

Completion equipment—including pumps, storage vessels, and related equipment—is now in place or mobilising to the Bruins Well location. 24-hour operations are scheduled to commence next week. Targeting the Woodford Formation, the Bruins Well will be completed using high-intensity, multi-stage hydraulic fracturing (plug-and-perforate method).

### Forward Operations

Following completion, crews will demobilise to make way for the drill-out of isolation plugs. Once plug removal is complete, production tubing will be installed, and flowback operations will begin.

These steps will pave the way for initial production and sales, which remain scheduled for the second quarter.

Development Unit or DSU	Development Unit or drilling spacing unit is the geographical area in which an initial oil and/or gas well is drilled and produced from the geological formation listed in a spacing order. The spacing unit communitizes all interest owners for the purpose of sharing in production from oil and/or gas wells in the unit. A spacing order establishes the size of the unit; names the formations included in the unit; divides the ownership of the unit for the formations into the "royalty interest" and the "working interest;" Only one well can be drilled and completed in each common source of supply. Additional wells may be drilled in a Development Unit, but only after an Increased Density Order is issued by the Oklahoma Corporation Commission.
Force Pooled	The Oklahoma Corporation Commission is authorized to establish well spacing and drilling units covering any common source of supply of hydrocarbons, or any prospective common source of supply. Once the unit is established, the Commission can force pool the interests of all the owners who own interests in that unit and who have not voluntarily joined in the development of that unit.
