## **Austco Healthcare Signs New Supplier Agreement with Leading US Healthcare Provider**

### **Key Highlights:**

- Austco Healthcare has renewed a preferred supplier agreement with a major US healthcare and hospital operator.
- Agreement includes the ongoing supply and support of Tacera IP Nurse Call systems to ~180 healthcare facilities across more than 30 US states.
- Builds on the past 5-year agreement that generated over A\$49 million in revenue.
- Further solidifies Austco's role as a global leader in digital nurse call and patient management solutions.

Austco Healthcare Limited (ASX: AHC) is pleased to announce that its wholly owned US subsidiary, Austco Marketing and Services (USA) Ltd, has renewed the Purchase and Maintenance Agreement with one of the largest healthcare service providers in the United States.

Under the agreement, Austco will continue delivering its industry-leading Tacera IP Nurse Call system and Tacera Pulse software platform to approximately 180 hospitals across more than 30 US states. This renewed and expanded contract reflects the ongoing commitment between Austco and our largest customer.

The Tacera Pulse platform empowers healthcare facilities to monitor alarms, analyse response data, and track key performance indicators (KPIs), enabling improved patient care and operational efficiency.

This agreement builds on the original agreement announced to the ASX on 13 February 2020. The agreement extends a strong, long-term partnership that has generated over A\$49 million in revenue for Austco over the past 5 years. As with previous arrangements, there are no minimum purchase commitments, allowing for commercial flexibility.

The Company is proactively responding to ongoing US-China tariff challenges by shifting production to contract manufacturers outside of China. This transition is already underway and is expected to be completed within the next 2 to 3 months.

The Company confirms that it does not consider the identity of the counterparty to be information that a reasonable person would expect to have a material effect on the price or value of its securities. The Company also confirms that the announcement contains all material information relevant to assessing the impact of the agreement on the price or value of its securities and is not misleading by omission.

**Clayton Astles, Chief Executive Officer, commented:**

“We are excited to continue our strategic partnership through this new agreement. It underscores the strength of our technology, the value of our services, and the trust we’ve built with one of the largest healthcare providers in the US. This milestone aligns with our strategy to grow our presence in key global markets.”
