REQUEST FOR VOLUNTARY SUSPENSION OF SECURITIES – ALVO MINERALS LIMITED (ASX: ALV)

Pursuant to ASX Listing Rule 17.2, Alvo Minerals Limited (ASX: ALV) (“**Alvo**” or the “**Company**”) advises that:

Further to the request for a trading halt dated 15 May 2025, the Company now requests an immediate voluntary suspension in the ordinary shares of the Company and in accordance with ASX Listing Rule 17.2 and provides the following information:

- The voluntary suspension is being requested to finalise the details of the Entitlement Offer and as the Company is not yet in a position to be able to make an announcement regarding progress on the Lavra Velha Project (**Announcement**); and
- the Company anticipates that the voluntary suspension will remain in place until the earlier of the commencement of trading on Friday, 23 May 2025 or until the release of an Announcement; and
- The Company is not aware of any reason why the voluntary suspension should not be granted or of any other information necessary to inform the market about the voluntary suspension.
