Successful completion of Campbellfield assets sale

Top Shelf International Holdings Ltd (**Top Shelf** or the **Company**) announces that it has now completed the sale of its plant and equipment at its Campbellfield production facility to Idyll Wine Co Pty Ltd (**IDL**) for gross proceeds of \$8.0 million.

\$3.2 million of the gross proceeds of the sale have been applied to fully eliminating the Company's outstanding ATO excise liability, which is now settled in full, reflecting a total repayment of \$4.8 million. The remaining balance of the total \$8.0 million in proceeds will be applied towards reducing other debts.

The sale includes all operational and production assets at the Company's Campbellfield facility, inclusive of its canning and bottling lines, brewhouse and distillery and a small portion of its excess bulk whisky inventory, but excludes the Company's whisky maturation and warehouse facility at Somerton.

As previously announced, Top Shelf agreed a co-packing arrangement with IDL for the ongoing production of Top Shelf's branded products, which is now in effect.

Commenting on the transaction, Top Shelf Chairman Julian Davidson said:

"Completion of the Campbellfield sale transaction is a significant milestone in the cost reduction program being rolled out by the Company, allowing full repayment of ATO debt and for some repayment to senior secured lender, Longreach Credit Investors, a key step in the of the ongoing financial and operational restructuring of the business. Further details of other capital, debt and operational changes will be progressively announced to the market as they are finalised."
