### Geoffrey Jamieson appointed CFO

**Orcoda Limited (ASX: ODA)** ('Orcoda' or the 'Company'), the resources, healthcare, and transport logistics and transport services optimisation Company, is pleased to announce that Managing Director ("MD") Geoffrey Jamieson has been appointed by the Board to take on the joint role of MD and Chief Financial Officer ("CFO").
