### Notice of Second Meeting of Creditors

I refer to the appointment of Kathryn Evans, Kate Warwick, David McGrath and I, Vaughan Strawbridge, as Joint and Several Administrators of Mosaic Brands Limited (ASX:MOZ) and the companies in the Schedule A (“the Companies”) on 28 October 2024 pursuant to section 436A of the *Corporations Act 2001 (Cth)* (“the Act”).
