archTIS Successfully Enters UK Market with Defence Industry Award Following Recent U.S. DoD Win

UK Division of a Global Aerospace and Defence Corporation Selects NC Protect to Meet UK Ministry of Defence Data Security Requirements in Microsoft 365

HIGHLIGHTS:

- **archTIS has secured a 3-year NC Protect contract with a UK-based aerospace and defence corporation as part of a global cloud migration.**
- **Initial contract is valued at A\$263,185 for 400 users, although the implementation is expected to serve as the global model for Microsoft 365 deployment across an enterprise of 100,000+ employees.**
- **Follows the recent U.S. Department of Defense (DoD) contract win, evidencing growing global demand for NC Protect's data-centric security capabilities across Western defence and industrial base organisations.**

archTIS Limited (ASX:AR9, OTCQB:ARHLF) ("archTIS" or the "Company"), a global provider of data-centric software solutions for the secure collaboration of sensitive information, is pleased to announce that the Company has entered a 3-year contractual agreement (the "Agreement") with the UK division of a large multinational aerospace and defence corporation for its NC Protect product.

This latest win builds on the Company's recent U.S. DoD contract and underscores the accelerating global adoption of archTIS technologies across military alliances and the defence industrial base. NC Protect's unique attribute-based access control (ABAC) capabilities are increasingly being recognised as critical in helping government and enterprise clients securely manage sensitive data in modern collaboration platforms such as Microsoft 365.

The 3-year contract which contains a cancellation for convenience clause is valued at A\$261,870, includes an initial 400 user licenses for NC Protect. This award follows the successful completion of a product proof of concept (POC). NC Protect will be deployed as a key component in the UK corporation's enterprise-wide migration from Microsoft SharePoint Server (on-premises) to Microsoft 365 cloud services. The initial implementation is expected to serve as the global reference model for securing data collaboration across a subsequent workforce of more than 100,000 employees.

The solution was selected to ensure compliance with the UK Ministry of Defence (MOD) Joint Service Publication 440 (JSP 440), which mandates the use of fine-grained access controls to more securely manage export-controlled and sensitive defence data. NC Protect was chosen for its ability to enforce fine-grained, attribute-based access control and dynamic file protection within Microsoft 365, providing an additional layer of security beyond native capabilities.
