**Takeover Offer by Hutchison Telecommunications (Amsterdam) B.V. in relation to Hutchison Telecommunications (Australia) Limited – Freeing Offer of Defeating Conditions**

We act for Hutchison Telecommunications (Amsterdam) B.V. (**HTABV**), an indirect wholly-owned subsidiary of CK Hutchison Holdings Limited.

We refer to the off-market takeover bid made by HTABV for all of the ordinary shares it does not already own in Hutchison Telecommunications (Australia) Limited (ACN 003 677 227) (ASX:HTA) (**Offer**).

On behalf of HTABV, we enclose a notice pursuant to section 650F of the *Corporations Act 2001* (Cth) freeing the Offer from the defeating conditions contained in paragraphs (b) and (c) of section 10.6 of the Bidder's Statement dated 22 May 2025, being the defeating conditions that, between the date of the Bidder's Statement and the end of the Offer period (each inclusive), there are no prescribed occurrences in relation to HTAL and no dividends are made, determined as payable, or declared by HTAL.

Accordingly, the Offer is now unconditional.

## Corporations Act 2001 (Cth)

### Section 650F

#### Freeing Offer of Defeating Conditions

Hutchison Telecommunications (Amsterdam) B.V. (**HTABV**) gives notice in accordance with section 650F of the *Corporations Act 2001* (Cth) (**Corporations Act**) in relation to the offers made by HTABV under its off-market takeover bid for all of the ordinary shares it does not already own in Hutchison Telecommunications (Australia) Limited (ACN 003 677 227) (ASX:HTA) (**HTAL**) (collectively the **Offer**) as set out in the Bidder's Statement dated 22 May 2025 (**Bidder's Statement**).

HTABV gives notice under section 650F of the Corporations Act that:

- 1 As announced on 23 June 2025, the defeating condition in section 10.6(a) of the Bidder's Statement (*minimum 97% relevant interest*) has been satisfied.
- 2 HTABV declares today that the Offer is free from the following defeating conditions in section 10.6 of the Bidder's Statement:
  - (a) the condition in section 10.6(b) (*no prescribed occurrences between the date of the Bidder's Statement and the end of the Offer period*); and
  - (b) the condition in section 10.6(c) of the Bidder's Statement (*no dividends between the date of the Bidder's Statement and the end of the Offer period*).
- 3 Accordingly, the Offer is now unconditional.
- 4 HTABV's voting power in HTAL as at the date of this notice is 98.54%.
