Aerometrex agreement with Landchecker renewed in multi-million dollar Metromap subscription that significantly boosts AMX's annual recurring revenue

- Aerometrex agreement with Landchecker renewed early with an extended contract term.
- Increase in the minimum commitment to \$3.0 million through to FY27. There is an option to extend through to FY29 with a minimum commitment of over \$3.2 million.
- Variable licence fee remains in place for licences above the fixed licence limit.
- Contract extended for an additional year beyond the original agreement with the option for a further two years beyond.
- Highly successful partnership between Landchecker and Aerometrex demonstrates Aerometrex's ability to expand its indirect customer base through its partnership program.

Aerometrex Limited (ASX: AMX) is pleased to announce that it has renewed its agreement with Landchecker through to 30 June 2027 with the option of a further two years. The early renewal replaces the final year of the previous agreement and extends for a further year with an increase in the minimum commitment to \$3.0 million for the next 2 years. An option for an additional two years with a minimum commitment of \$3.2 million would extend the agreement to 30 June 2029.

Key Terms

The renewed agreement continues to see Landchecker purchasing from Aerometrex a fixed number of tailored MetroMap licences and for Landchecker to purchase additional licences above the fixed amount during the term of the agreement. These licences will continue to be offered through the Landchecker platform to its customers.

The key terms include:

- 1. Landchecker will pay to Aerometrex a minimum annual payment fee of \$1.5 million for the fixed number of licences for FY26 and FY27.
- 2. Landchecker can purchase additional licences above the fixed amount at an agreed price per licence, thereby enabling additional revenue opportunities for Aerometrex and Landchecker over the contract term.
- 3. The number of additional licences that Landchecker can purchase from Aerometrex above the fixed licence quantity is uncapped.
- 4. Updated agreement expiry date is 30 June 2027 with the option for a further two years to 30 June 2029
- 5. Other general terms and conditions are customary with agreements of this nature.

The continued success of the partnership with Landchecker is a clear endorsement of Aerometrex's partnership program which seeks to accelerate its indirect customer growth through partnering with leading Australian analytics companies that require market leading aerial imagery fundamental to their business.

Agreement Commentary

Aerometrex's Acting Chief Executive Officer, Rob Veitch said:

"Landchecker is an important strategic MetroMap partner and we are pleased to continue this relationship. The ongoing relationship between Aerometrex and Landchecker highlights the strength of the partner model in supporting our partner's business grow which in turn delivers revenue and ACV growth for Aerometrex."

Landchecker's Chief Executive Officer, Adam Gandolfo said:

"We are excited to be continuing our relationship with Aerometrex. MetroMap's high resolution imagery is embedded into the Landchecker offering and our customers engage with the imagery on a daily basis."
