PME signs \$20M, 5-year contract renewal with Franciscan Missionaries of Our Lady Health System

Leading health imaging company Pro Medicus Limited [ASX: PME] today announced its wholly owned U.S. subsidiary, Visage Imaging, Inc., has signed a 5-year contract renewal and a new Visage 7 Open Archive contract with Louisiana based Franciscan Missionaries of Our Lady Health System ("FMOLHS"). The contract has a minimum value of A\$20M.

Both the renewal of the Visage 7 Viewer, negotiated at a higher per transaction cost and the new contract for Visage 7 Open Archive are transaction-based. As part of the deal, FMOLHS's current on-premise instance of Visage 7 will be deployed in the cloud along with Visage 7 Open Archive.

Planning for the rollout is to commence immediately and will involve the migration of FMOLHS's current archive to Visage 7 Open Archive.

"This deal confirms our belief that there is a material opportunity for us to sell Visage 7 Open Archive to our existing base of "viewer only" clients," said Dr Sam Hupert, Pro Medicus CEO. "Over time, we believe those customers with on premise implementations will join FMOLHS and a growing number of existing clients in transitioning to cloud, a trend we see continuing."
