# PME signs A\$170M, 10-year contract with Colorado-based UCHealth

Leading health imaging company Pro Medicus Limited [ASX: PME] today announced its whollyowned U.S. subsidiary, Visage Imaging, Inc., has signed a A\$170M, 10-year contract with Colorado based UCHealth,

UCHealth spans a network of fourteen (14) hospitals, with affiliate hospitals, clinic locations and health care providers extending throughout Colorado, Wyoming, and western Nebraska.

UCHealth's unique combination of academic-based and community-focused medicine, brings leading-edge care to patients throughout the Rocky Mountain region. This includes University of Colorado Hospital, an innovative academic medical center that provides advanced research, clinical trials and treatments not offered by others in its multi-state region.

Based on a transactional licensing model, the contract will see the company's cloud-based Visage 7 Enterprise Imaging Platform ('Visage 7'), including Visage 7 Viewer, Visage 7 Workflow, Visage 7 Open Archive, and Visage 7 Cardiology Imaging implemented throughout UCHealth providing a single, unified enterprise imaging platform. The contract also includes migration of UCHealth's legacy PACS archive to Visage 7 Open Archive as well as enterprise distribution of images integrated into UCHealth's electronic health record (EHR).

Planning for the rollout is to commence immediately and will be based on Visage's proven cloudbased implementation process, with go-live targeted for Q2 of the 2026 calendar year.

"UCHealth is a very highly regarded health system providing outstanding care to patients in the Rocky Mountain region of the U.S.," said Dr Sam Hupert, Pro Medicus CEO.
