The license agreement has a base value of AUD \$375,000 and requires Activeport install its software at Ishan including the Core, Network Fabric, IP Transit, NOC Management and Cloud Router modules. Additional license fees will accrue on a per device per month basis. The license is valid for an initial 60 month term. Activeport anticipates no material additional overhead to deliver the services. Termination clauses are common to contracts of these types including termination for breach, change of ownership and insolvency.
