## archTIS Completes \$7.5M Capital Raising

**archTIS Limited (ASX:AR9, OTCQB:ARHLF)**, a global provider of data-centric software solutions for the secure collaboration of sensitive information, is pleased to confirm that it has successfully completed the capital raising announced on 1 July 2025.

The Company has today issued 50,000,000 fully paid ordinary shares in the capital of the Company ("**Securities**") at an issue price of \$0.15 per share to raise \$7.5 million (before costs). The capital raising was supported by new and existing institutional, key company executives and sophisticated investors.

The capital raise is a pivotal step forward for the Company to execute its three core goals for international growth, which include U.S. expansion and support, strategic partnerships, and product development. archTIS looks forward to providing shareholders with updates as it progresses.
