RBR Group Limited Announces Share Purchase Plan to Raise Up to \$650,000

RBR Group Limited (ASX:RBR) (**RBR** or the **Company**) is pleased to announce the launch of a Share Purchase Plan (**SPP**) to raise up to \$650,000. The SPP provides Eligible Shareholders with an opportunity to subscribe for up to \$30,000 worth of fully paid ordinary shares in the Company at an issue price of \$0.001 per share, free of brokerage and transaction costs.

The issue price represents the volume weighted average price (**VWAP**) of RBR shares traded over the five trading days prior to the announcement of the SPP on 11 July 2025.
