The VG1 portfolio returned +6.1% in June,² with the long book contributing +5.9%, while the short book returned +0.2%.

Global equity markets continued their recovery in June, driven by tentative US trade agreements, investor optimism around US Fed rate cuts and resilient economic growth coupled with little evidence of any consumer spend slowdown. US-Iran military strikes were also paused.

Positive contributors to performance in June included the portfolio's technology exposures, particularly to the semiconductor sector via SK Hynix and TSMC (both players in the artificial intelligence hardware value chain), as well as our large cap technology holdings (Amazon and Meta).

The portfolio also delivered strong contributions from its exposure to the online gaming sector (via Entain and Flutter) as well as long positions with exposure to the copper and uranium markets. Long positions across the gold sector detracted from returns during June as share prices of various gold miners pulled back following strong price moves in recent months.

We fully exited our position in UK online property portal business Rightmove during June, as our thesis has played out and we now believe the valuation fully reflects the quality of the business. Pleasingly, the stock has been a strong performer for the portfolio.

The portfolio's short book also contributed positively during June despite the strong rally in equity markets, reiterating our belief that short selling is another tool we can actively use to generate performance while mitigating risks.

Buy-back: In June, approximately 0.8m VG1 shares were bought at an average price of \$1.68.

FY25 result: VG1 expects to release its FY25 result on Wednesday, 20 August.

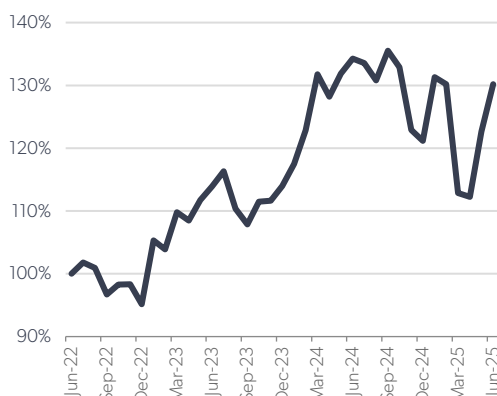
