As a result of Ms Gray not being aware of the purchases, the Purchases Appendices 3Y were not lodged with the ASX within the required time frame. The Sale Appendix 3Y is being lodged within the required time frame.

We are aware that CGF’s obligation was to file the Purchases Appendices 3Y within 5 business days of the change of director’s interest and we believe our processes to comply with Listing Rule 3.19A.2 are adequate and fit for purpose. Ms Gray has taken action to ensure that the Financial Planner obtains Ms Gray’s consent to all future share trade transactions.
