Capital Raising Update

Highlights:

- Tranche 2 of the previously announced placement increased by **A\$408,000** due to strong demand from new investors.
- Director **Simon Gerard** will increase investment to **A\$366,000** in Tranche 2 to maintain an ownership stake of 19.9%.

Zimi Limited (ASX: ZMM) ("Zimi" or "the Company"), an Australian company specialising in connecting IoT electrical products to create smarter living and working spaces, is pleased to announce that, further to its announcement on 4 July 2025 regarding a two-tranche placement to raise approximately A\$1.44 million at A\$0.006, Tranche 2 of the placement has been upsized by A\$408,000 due to strong investor demand.

The additional funds increase the total gross proceeds of the placement to A\$1.85 million for 308,500,000 ordinary shares. All new shares under Tranche 2 will be issued at A\$0.006 each, identical to the Tranche 1 issue price, and will rank equally with existing ordinary shares. Shares proposed to be issued under Tranche 2 are subject to shareholder approval.

As part of Tranche 2, Director Simon Gerard intends to subscribe for A\$366,000 in new shares to maintain ownership at 19.9%. This participation by a Director constitutes a related-party transaction and will be subject to shareholder approval.

Cerberus Advisory acted as lead manager to the offer. Adjusted for the additional funds to be received under the placement, Cerberus Advise will receive a total of 34,000,000 options at \$0.025 expiring 3 years from date of issue (subject to receipt of shareholder approval) (**Lead Manager Options**). Terms and conditions of the Lead Manager Options were included at Schedule 1 of the 4 July 2025 announcement.

Shareholder approval in respect of the issue of placement securities will be sought at an upcoming General Meeting. A notice of meeting will be dispatched to Shareholders in due course.
