8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

No. Although the calculation outlined in section 8.7 indicates that only two quarters of cash remain, it is expected that net operating expenses will rise in subsequent quarters as the Company transitions its flagship Lance Project from development and pre-production expenditures (*classified as investing activities*) to uranium dry yellow cake production.

On the 10th of July 2025 the Company announced it had secured a debt financing facility of up to US\$15 million to enable development and commissioning work at the flagship Lance Project to continue whilst progressing matters including the reset of the contract sales book, production guidance, together with other associated plans that are required to enable the launch of an anticipated equity raise.

The Company anticipates the production of dry yellow cake will commence prior to the end of August, subject to final approvals and the successful hot commissioning of the central processing plant.
