
June 2025 Quarterly Activities Report

Key Developments:

- **Arbitration proceedings for the Kvanefjeld Rare Earths Project in Greenland progressed with an oral hearing held in Copenhagen.**
- **ETM Spain recommended as the preferred bidder for the acquisition of the Penouta Tin-Tantalum-Niobium Project in Galicia.**

Energy Transition Minerals Ltd (**ETM** or 'the **Company**') is pleased to present its Quarterly Activities Report for the quarter ending 30 June 2025.

Projects

Kvanefjeld Rare Earths Project, Greenland

Kvanefjeld – Legal Proceedings and Arbitration Update

During the quarter, material progress was made in the legal processes associated with the Kvanefjeld Rare Earths Project. An oral hearing on arbitral jurisdiction was held on 25–26 June 2025 in Copenhagen. The hearing concerned whether the arbitral tribunal has the authority to decide GMAS's entitlement to an exploitation licence and associated damages.

A decision on jurisdiction is expected by September 2025. The outcome of this decision will determine if the arbitration will either proceed on the merits, be terminated, or stayed pending the outcome of parallel litigation.

Separately, GMAS's litigation in Greenland, initiated in May 2024, is expected to proceed with a case management conference anticipated by August 2025. The litigation in Denmark, also filed in May 2024, is expected to be stayed within six months pending the outcome of either the arbitration or the Greenlandic proceedings.

During the quarter, Greenland Minerals A/S (GMAS), a subsidiary of ETM finalised a guarantee for costs in the amount of DKK25,000,000 (equivalent to approximately A\$5.88 million). This guarantee was ordered by the Arbitral Tribunal in early 2024 for security for costs to the governments of Denmark and Greenland in respect of any potential adverse costs order that may be made against GMAS if it were to be unsuccessful in the arbitration proceedings.

Operational Readiness and Community Engagement

ETM's technical team visited Greenland and Denmark in Q2 2025 to advance preparations for the 2025 northern summer fieldwork campaign.

Engagement with stakeholders, including local authorities and communities, continues to be a key focus to ensure transparent communications and long-term alignment.



Solo and Good Setting Lithium Projects, James Bay, Canada

The Company identified several prospective sites during the first summer field reconnaissance program across its 100%-owned Solo and Good Setting claims, located in the highly prospective James Bay region of Quebec, Canada. No substantive on-ground activities were undertaken at these projects during the June 2025 Quarter. The Company continues to assess its future plans and potential follow-up at prospective sites at these Projects in light of current lithium market conditions.

The Solo Project is located within the La Grande sub-province of the Superior Geological Province, southern Eastmain River domain. The Good Setting Project is located within the Opinaca sub-province of the Superior Geological Province, which is characterized by paragneiss and migmatites intruded by syn- to post-tectonic intrusions.

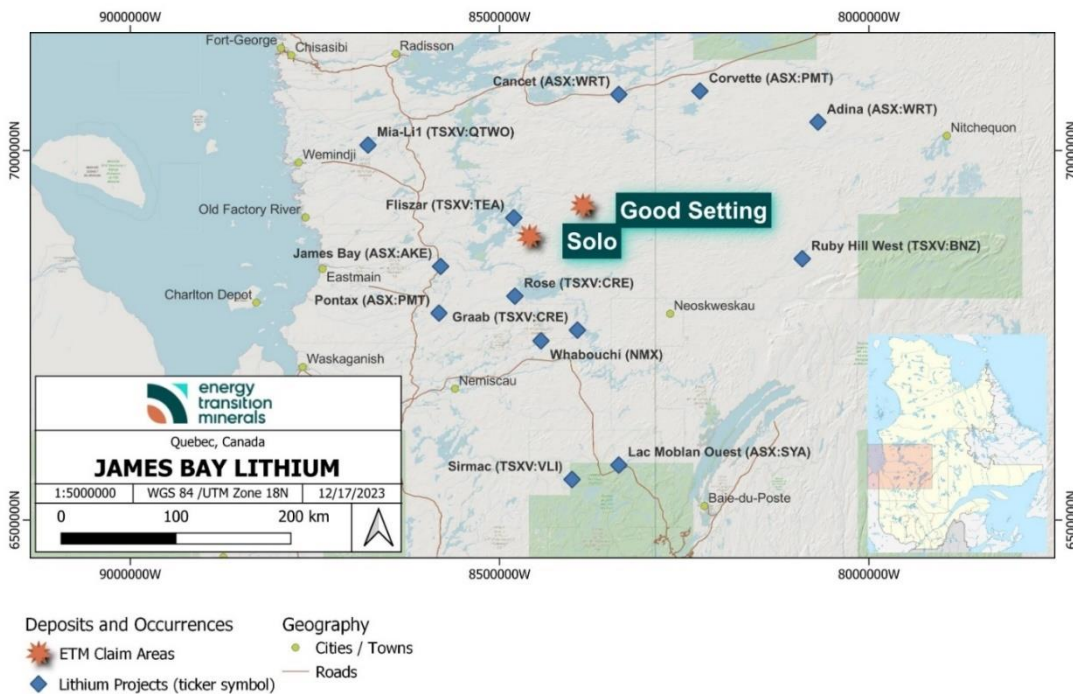


Figure 1: Location of the Good Setting and Solo Projects in James Bay, Quebec

Villasrubias, Spain

During the Quarter, the Company continued assessment and planning activities for its Villasrubias Lithium Project, located in Salamanca, Western Spain. No substantive on-ground activities were undertaken during the quarter.

The Villasrubias exploration licence was successfully renewed in May 2025 for a further 3-year period, demonstrating that sufficient exploration works have been completed to satisfy the minimum exploration requirements.

Additionally, ETM is in discussions to extend the earn-in for the project. The aim is to conserve company funds during current lithium market conditions, while still meeting the minimum expenditure obligations.



The Company has previously announced the results from its second drilling program, completed in June 2024 (refer to ASX Release dated 18 September 2024).

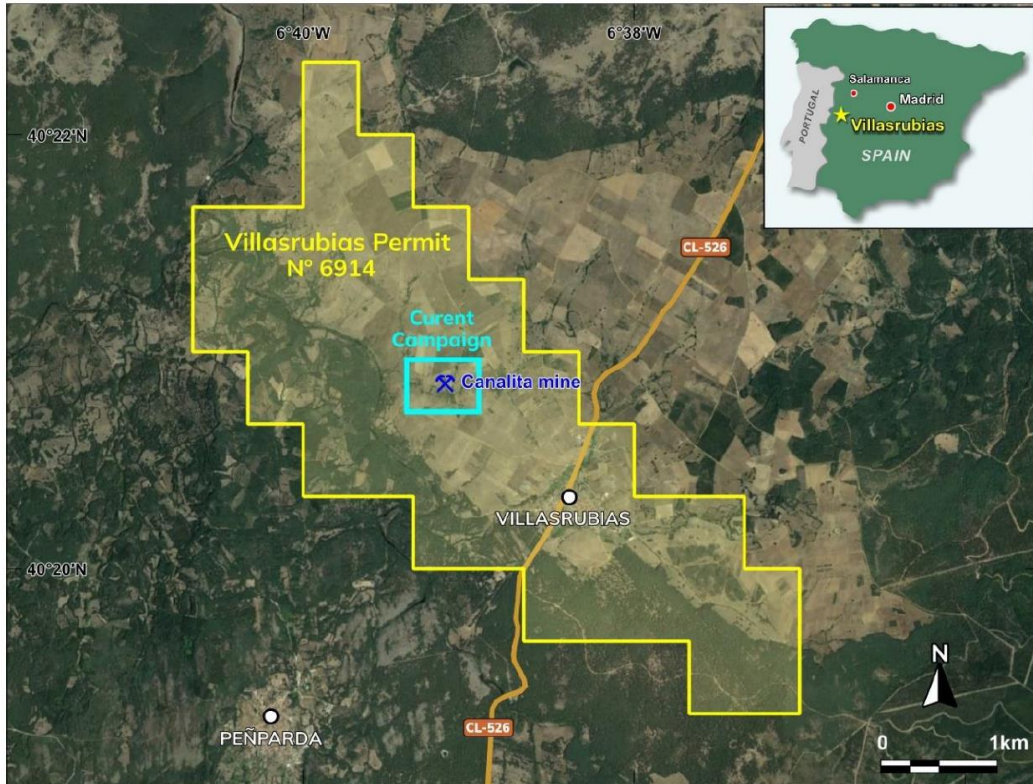


Figure 2: Location of Villasrubias Project

Events Subsequent to Quarter-End

Penouta Mine Acquisition Process

Subsequent to the end of the quarter, on 14 July 2025 the Company confirmed that its wholly-owned subsidiary, Energy Transition Minerals Spain S.L ('ETM Spain'), had submitted a conditional binding offer to acquire the Penouta Tin-Tantalum-Niobium Mine, located in north-western Spain, and had been granted Qualified Bidder Status.

On 18 July 2025, ETM Spain was formally recommended as the preferred bidder by the court-appointed administrator overseeing the Strategic Minerals insolvency process.

The final court decision, following a live auction scheduled for 29 July 2025, is expected by October 2025. Completion remains subject to the execution of a sale and purchase deed, regulatory consents, and judicial approval.

The proposed acquisition aligns with the Company's strategy to diversify its critical minerals portfolio in support of energy transition markets, adding potential to extract tin, tantalum and niobium, considered important critical minerals. The proposed acquisition is valued at up to €3.6 million (approx. A\$6.4 million) and is conditional upon regulatory approvals, final judicial confirmation, and execution of sale documentation.



Corporate

Securities Update

During the quarter, the Company issued 1,200,000 ordinary fully paid shares (ASX: ETM) on 16 April 2025 following the conversion of performance rights.

On 24 June 2025, 32,666,667 performance rights (ASX: ETMAC) expired unexercised.

Board and Governance

Effective from 14 April 2025, Ms. Jessamyn Lyons was appointed as Company Secretary, joining Mr. Ryan Sebbes in a dual role. Ms. Marie Forsyth resigned from her position on the same date.
