CAQ Holdings Limited June 2025 Quarter Activities Report

Operations Review

The property leasing business decrease in June 2025 Quarter. Leasing revenue totalled RMB1.3 million (AUD 277.1k) during the June 2025 Quarter, which represented a reduction of approximately 35%, from RMB2.0 million (AUD 426.3k) in the March 2025 Quarter. The decrease was due to the change of charge rate by a warehouse tenant upon the renewal of new lease in November 2024, New lease was charged based on volume of goods stored in the warehouse instead of area occupied, and since April 2025 there was no new goods kept in the warehouse so nil lease income was received in June 2025 Quarter.

The status of the exhibition centre remained unchanged from the March 2025 Quarter, the system integration testing was suspended pending release of new government customs requirements.

The National Development and Reform Commission of PRC announced on 23 July 2025 that the Hainan Free Trade Port will launch island-wide independent customs operation on Dec. 18, 2025 and since then, the proportion of tariff lines with zero-tariff products in Hainan Free Trade Port will increase from 21 percent to 74 percent. Imported products that undergo at least 30 percent value-added processing in Hainan can enter the mainland tariff-free. Certain goods currently banned or restricted nationwide will enjoy open policies in Hainan. A series of favourable policies will be announced in subsequent months. Following the gradual confirmation of the policies, it was believed the negotiation of the contracts of potential tenants will be fastened and the vacant areas in future will be decreased, thus increased the income of the Company.

During the June 2025 Quarter CAQ's receipts from customers was \$0.27m (RMB1.3 million) which was decreased from the March 2025 Quarter \$0.46m (RMB2.0 million).

Financial

At the end of the Quarter the Group had cash at bank of \$0.055m.

Payments to director related parties and their associates during the quarter totalled \$Nil.
